Terms and Conditions of Use

THESE TERMS AND CONDITIONS OF USE GOVERN THE USE OF THE REGISTER AND ITS CONTENTS. PLEASE READ THEM CAREFULLY.

1. About the Register

The Register, located at <https://publicspace.who.int/sites/gem>, provides access to a central database that collates information on the engagement of the World Health Organization (WHO) with non-State actors, with a view to manage this interaction in a transparent manner.

The information contained in the Register originates from both inside WHO and from non-State actors sources. The information is, in some cases, publicly available, and in other cases has been provided to WHO for dissemination through the Register, subject to certain conditions.

Information regarding a non-State actor has been provided by that non-State actor itself, and the accuracy and completeness of such information is the sole responsibility of that non-State actor, not WHO.

2. Use of the Register and acceptance of these Terms and Conditions of Use

The use of the Register is conditional upon acceptance and compliance with these Terms and Conditions of Use, and by accessing or otherwise using the Register you agree to these Terms and Conditions of Use, and form an agreement (hereinafter, “this Agreement”) with WHO.

If you enter into this Agreement on behalf of a third party (including, without limitation, an employer, a client, or an organization), you confirm (represent and warrant) that you are authorized by that third party to enter into this Agreement on their behalf. In such a case, the terms “you” and “your” in this Agreement refer to, and this Agreement applies to, that third party.

WHO may amend these Terms and Conditions of Use at any time by posting an amended version of the terms on the Register website. You should visit the Register website periodically to review the current Terms and Conditions of Use.

These Terms and Conditions of Use are effective until terminated by WHO. All restrictions, disclaimers, and limitations of liability set out in these Terms and Conditions of Use will survive any such termination.

3. Conditions on your use of the Register

Your use of the Register is subject to these Terms and Conditions of Use.

WHO makes the Register available to the public, and all information provided on the Register is available free of charge, and may be copied, modified, and/or distributed, subject to these Terms and Conditions of Use.

In no event shall you use the Register:

- a. In any manner which infringes the rights of any person or entity, including the rights of WHO and the attributed owner(s) of Register information;
- b. In, or in association with, any product marketing, promotional, or commercial activities, including, without limitation, in, or in association with, advertisements, product brochures, company-sponsored websites, annual reports, or other publications, non-educational publications or distributions;
- c. In, or in connection with, the promotion of a commercial enterprise and/or its product(s) or service(s), and/or in any way that suggests that WHO endorses any specific company or products;

5. Updates and revisions to, and limitations of, the Register

WHO periodically incorporates, without notice, revisions, updates and improvements to the Register's content, but undertakes no obligation to do so, on a timely basis or at all.

WHO will make every reasonable effort to provide continuous access to the Register. There will, however, be occasions when the Register will be unavailable for use (including for

maintenance). Furthermore, WHO may decide, at any time and its sole discretion, to cease hosting the Register, or to change, delete an entry or discontinue any feature of the Register.

6. WHO disclaimers and limitation of liability relating to the Register

WHO does not guarantee or make any express or implied representations regarding the accuracy, reliability, correctness, fitness for use for a particular purpose, or otherwise, whatsoever, of the Register or Register information. The arbitration shall be conducted in accordance with the modalities to be agreed upon by the parties or, in the absence of agreement, with the rules of arbitration of the International Chamber of Commerce. The parties shall accept the arbitral award as final.
